AN ORDINANCE AMENDING THE CODE OF THE TOWN OF JEROME, ARIZONA ORDINANCE #198 SECTION 13-3-2 PAYMENT RESPONSIBILITY, TO PROVIDE THAT THE RECORD OWNER OF REAL PROPERTY SHALL BE RESPONSIBLE FOR THE PAYMENT OF WATER, SEWER AND GARBAGE COLLECTION FEES TO SAID PROPERTY, PROVIDING FOR TERMINATION OF SAID SERVICES EVEN IF SAID PROPERTY IS LEASED, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF JEROME, YAVAPAI COUNTY, ARIZONA, AS FOLLOWS:

SECTION 1:

That Section 13-3-2 of the Code of the Town of Jerome is amended to read as follows.

Section 13-3-2 PAYMENT RESPONSIBILITIES

The record owner of all real property receiving Town Utilities Services including water, sewer service and/or garbage collection service shall be ultimately responsible for payment of charges for said services to the Town, regardless of who resides at the property. In the event the record owner leases said property or a portion thereof, the record owner shall notify the Town and the record owner shall further advise the Town of the termination of the tenant's occupancy, the record owner shall be billed for the utilities and services.

SECTION 2: EMERGENCY

WHEREAS it is necessary for the preservation of the peace, health and safety of the Town of Jerome that this ordinance
